

### NOTICE OF AVAILABILITY OF A SECTION 4(F) DE MINIMIS DETERMINATION FOR SONOMA 1 CULVERT REHABILITATION PROJECT

The California Department of Transportation (Caltrans) proposes to replace 23 culverts along State Route (SR) 1 between Mill Gulch (Post Mile [PM] 30.8) and 0.5 miles south of Miller Creek (PM 40.6) in Sonoma County, California for the Sonoma 1 Culvert Rehabilitation Project (the Project). The Project would replace in kind or upgrade to the appropriate size 23 culverts, seven of which would be located within three Section 4(f) properties.

# WHY THIS AD?

Caltrans has studied the effects the Project may have on the environment. This public notice is to tell you of Caltrans' intent to adopt a U.S. Department of Transportation Act Section 4(f) *De Minimis* finding and of its availability for you to review and provide comments.

Section 4(f) of the U.S. Department of Transportation Act of 1966 seeks to protect publicly owned parks and recreation areas, wildlife refuges, and historic sites that are eligible for the National Register of Historic



Places. Provisions to carry out this evaluation are recorded in 23 Code of Federal Regulations (CFR) 774.17, Section 4(f). As part of the Safe, Accountable and Efficient Transportation Equity Act – A Legacy for Users (SAFETEA\_LU ACT) of 2005, the legislature established the *de minimis* finding process, in which determinations are made regarding 4(f) resources when no adverse effects would occur. *De Minimis* impacts are defined as those that do not adversely affect the activities, features and attributes for which the property qualifies as a 4(f) resource.

Caltrans has determined that the Project will require six permanent drainage easements (PDEs) and one temporary construction easement (TCE) within California Department of Parks and Recreation (State Parks) right-of-way (ROW) on Fort Ross Historic State Park and Salt Point State Park and Sonoma County Regional Parks ROW on Stillwater Cove Regional Park, Section 4(f) properties. No existing public trails or roads are located within the six PDEs and one TCE and therefore would not restrict recreation uses of the three Section 4(f) properties. Caltrans has analyzed the use that the Project would have on these three Section 4(f) properties and has determined that the six PDEs within State Parks ROW on Fort Ross Historic State Park and Sonoma County Regional Parks ROW on Stillwater Cove Regional Parks and Sonoma County Regional Parks ROW on Stillwater Cove Regional Parks ROW on Stillwater Cove Regional Parks and Sonoma County Regional Parks ROW on Stillwater Cove Regional
