## District 11 Highlight – Everett Townsend, Acting Deputy Director of District 11

- Gustavo Dallarda retired at the end of 2023. Everett Townsend is acting Deputy Director of District 11.
  - District 11 Caltrans staff introduced:

- District 11 Small Business Highlight Video

  - Minor B Contracts
    - 54 contracts awarded
    - \$13,763,550 awarded to 46 Small Businesses (SB)
  - o 19th Annual Procurement and Resource Fair
    - 71 exhibitors including 9 primes, 9 resource partners, 25 public agency partners, and 28 Caltrans buyers/programs.
    - 463 attendees.
    - \$249,635 was spent on SBs that attended.

- In 2023, the District 11 Small Business Team participated in 38 outreach events and hosted 5 local SBC meetings.
  - FY 22/23 utilization
    - Small Business: 71.8%
    - Disabled Veteran Business Enterprise: 3.5%
    - Disadvantaged Business Enterprise: 30.5%

## Highlights from the Director's Office – Tony Tavares, Caltrans Director

- January is Dr. Martin Luther King Jr. Month
  - Dr. Martin Luther King Jr.'s legacy informs Caltrans and the work being done to improve equity in transportation.
- Winter Storms and Safety
  - In 2023, there were no worker fatalities but more than 4,000 people have died on California's roadways.
    - To achieve zero fatalities, Caltrans is implementing a "Safe System Approach:"
      - Humans make mistakes, are vulnerable, and responsibility is shared.
  - Caltrans routinely partners with CHP, CalFire, and regional and local agencies to respond to inclement weather and hazards.
    - There is always an opportunity for contractor involvement in emergency/maintenance work.
    - If you have not done so already Caltrans has an Emergency Contractor Registry at ocr.dot.ca.gov
- Climate Action
  - Governor Gavin Newsom announced \$40.5 million from the National Electric Vehicle Infrastructure (NEVI) program to build 270 electric vehicle (EV) fast chargers at 26 sites along state highways.
    - This will double the number of highway fast charging stations and encourage more motorists to drive EV vehicles.
  - In October, Caltrans signed a \$80 million contract to deliver the first zeroemission, hydrogen intercity passenger train in North America.
- Clean California
  - Since July 2021, Caltrans has removed an estimated 2 million cubic yards of litter from state highways –enough to fill 634 Olympic-size swimming pools.
  - The program has created more than 8,700 jobs that have helped Californians overcome barriers to employment and funded hundreds of projects to revitalize underserved communities.
- The 2024 Annual Transportation Research Board Meeting
  - o There were equity sessions on topics like bicycling, charging of electric vehicles, and innovation in accessible transportation.
  - o Topics discussed include:
    - Reducing greenhouse gas emissions

- Sustainability of asphalt pavements
- Artificial intelligence (from language translation to data visualization.)
- Caltrans Industry Safety Summit
  - Priorities include addressing work zone safety and the mental health/wellbeing of workers and contractors.
  - The Construction Zone Enhanced Enforcement Program (COZEEP) will be used to create safer work zones for our workers and motorists.
  - Summit will examine Cal/OSHA safety and Caltrans Standard Specifications enforcement.

- Mark Samuelson has been appointed Acting Deputy Director of Planning, Local Assistance, and Environmental Support in the Stockton area (District 10).
- Marlon Regisford is the new Deputy Director of Planning and Local Assistance in the Los Angeles area (District 7).
- Matt Rocco is the new Assistant Deputy Director of Public Affairs at Headquarters in Sacramento.

#### Questions and Comments:

- Will there be goals attached to contracts related to energy infrastructure in the future? (Zeke Patten)
  - There was a 25% goal on broadband contracts. With NEVI and EV charging, it would be the California Energy Commission (CEE) attaching goals. Caltrans is currently working with the CEE to have goals that include SBs. (Tony Tavares).
- Did SBs receive any broadband work across the state? (Lee Cunningham).
  - Currently, the Middle Mile Broadband Initiative (MMBI) is in the preconstruction phase. Once work orders go out, MMBI will track SB participation. (Tony Tavares).
- How can SBs find out when work is available and how to bid on contracts? (Rebecca Llewellyn).
  - Caltrans provides a look ahead on what projects are upcoming. (Tony Tavares).

- o The Professional Services Committee is aware and recognizes the 70% success rate on Minor B of 70% SB participation. The Committee, and the new chair, Trinity Nguyen, hope to assist this year. (Albert Leung).

## FHWA Update – Elissa Konove, Acting Director of Field Services – West

- The first quarter of the fiscal year (FY) through December was strong. Caltrans is just short of the 22% DBE goal.
- Program reviews and the implementation of B2GNOW are progressing.
- Congress recently passed another short-term spending bill to take the appropriation process through to the beginning of March.
  - FHWA is not reliant on bipartisan infrastructure law. Will maintain operations while watching the overall budget.
- Check the FHWA website for Notice of Funding Opportunities:

- California received another 70 grant awards.
  - o These are awards to local agencies, NPOs, and regions.
    - 14 capital projects under "Safe Streets for All" to continue to make improvements at the local level on safety projects.
- NEVI Program
  - \$65 million was awarded to Caltrans to replace and repair broken EV chargers.
    - This is a great opportunity for contractor involvement.
- The Manual on Uniform Traffic Control Devices (MUTCD) 11th edition
  - Recently updated with a focus on improving safety for all road users
  - o Addressing vulnerable road users and workers in work zones.
  - o This will be addressed at the Caltrans Safety Summit.

  - Effective October 1, 2023, AB 2019 voluntary diversity data collection has been enhanced with new FI\$Cal functionality to capture and display, in addition to the voluntary diversity information, other diversity certifications such as Disadvantaged Business Enterprise (DBE), Small Business Administration (SBA) 8(a), Minority Business Enterprises (MBE), Woman Business Enterprises (WBE), Lesbian, Gay, Bisexual, Transgender Business Enterprises (LGBTBE), and other non-State certifications.

- Statewide Supplier Diversity Program (SSDP) Update
  - Disparity study draft is under review.
  - o The RFP had a SB participation goal of 10% and a DVBE incentive.
- CA Supplier Diversity Symposium
  - Symposium is on March 14, 2024, from 8:30 a.m. to 3:00 p.m. at the Ziggurat Building, 707 3rd Street, West Sacramento, CA.
  - The event will be in-person and will feature a range of breakout sessions offering insights on contracting with the state, utilities, healthcare industries, and more.

#### Generative Al Update

- Executive Order N-12-23 was issued on September 6, 2023, specific to the State's processes around generative artificial intelligence.
  - California will study the development, uses and risks of AI
    technology statewide, and develop a deliberative and responsible
    process for the evaluation and deployment of AI within state
    government.
    - There will be disclosures when Generative AI is used in government work.

- The report will be published by the end of January and a public toolkit will be made available as well.
- Two RFI Projects Issued
  - Vulnerable Road User (VRU) Protection. Investigate near misses of injuries/fatalities to identify risky areas and monitor interventions designed to increase safety of vulnerable road users.

  - Traffic Management (Traffic Operations). Process and interpret complex data to improve traffic pattern analysis, address bottlenecks, and enhance overall traffic management.

- Questions and Comments:
  - Will the disparity study allow Caltrans to have demonstration projects and expand the DBE program? How far-reaching is the disparity study? (Fred Jordan).
    - The disparity study is addressing different areas across the state of California. The report will provide recommendations on how to increase numbers across the state. (Angela Shell).
      - Caltrans implements its own statewide transportationspecific disparity study. Caltrans needs recommendations on strategies to improve outcomes for bidding/participation.
         The Mentor-Protégé Program has been expanded and there are other efforts in progress now. (David DeLuz).
  - Generative artificial intelligence has many challenges, including wellresearched gender biases and biases against certain minority groups. Al should enable small businesses not hinder them. (Shaila Rao Mistry).
    - The tools of generative AI will be tested in a sandbox environment to observe how the data responds. It will identify whether the data is accurate or biased and the State will adapt processes to ensure guidance and training on how to manage future AI contracts. (Angela Shell).
  - Historically, DBEs were all classified as SBs because the size standard was so large. In the State portal, there are ways to track which certifications are attached to SBs and DBEs. There should be an easier way to do this. (Lee Cunningham).

  - o Have you set a goal for the procurement of trains? (Fred Jordan).
    - When the RFP is released the goal structure will be identified. (Catrina Blair).
      - Encourage members of your chambers to become dually certified now. Many of the opportunities available are more beneficial if businesses are dually certified. (David DeLuz).

- Questions and Comments:
  - When did these groups begin being referred to as SED? (Zeke Patten).
    - SED refers to socially and economically disadvantaged groups. It is used to differentiate categories. (Aisha Copeland)
      - This is a federal designation. It describes 6 categories that are measured. (David DeLuz).
  - o In reference to the District 43 and District 59 reports, there are 0 DBE and 0 DVBE participation contracts awarded. What is the cause behind this? In addition, D59 was awarded 1 contract totaling \$28 million. Are there opportunities for primes to work with small businesses? (Albert Leung)
    - Aisha Copeland will look at the backup data and provide the information later.
    - Regarding District 59, there is discussion of unbundling in Professional Services. District 59 is DES and they have unbundled in the past. Uncertain of the situation with the \$28 million. (David Prizmich).
  - How did District 11 get 38 contracts? The number of occurrences is impressive. (Lee Cunningham).
    - This is due to the hard work of the District 11 SB team and the Minor B team. District 11 is committed to increasing SB partnership. (Everett Townsend).
  - Can all the data shared be consolidated into one document electronically? (Albert Leung).
    - Yes. (Aisha Copeland).

# SBC Topic: Large Group Discussion - David DeLuz

- Ideas for the 2024 SBC Topic
  - Bonding Assistance Program
    - Restarting this program would provide access to real capital.
    - The program would include bonding and insurance.

- A partnership between OCR and the Office of the Treasurer and the Office of the Governor would bring together resources to increase SB capacity building.
- In the past, when Primes won a contract, DPAC sent a letter to inform that a contract had been awarded. This has since been discontinued. Can you look into this? (Johnathan Hou).
  - David Prizmich will investigate this.
- Is it possible for DPAC to provide a progress update on the A&E attainment every 6 months? Does B2GNOW do this? (Johnathan Hou).
  - B2GNOW may be able to do that. Once DPAC executes a contract, it moves on. DPAC may be able to find out how to produce what you are asking for. (David Prizmich).
- Design-Build and the goals are not always clear. Is that something that SB could work on? (Rebecca Llewellyn).
  - Caltrans has been participating in FHWA's Every Day Counts 7 (EDC), looking at innovations to the DBE program as part of the Design-Build process. Caltrans is attempting to improve outreach, communication, monitoring, and guidance on how to work with prime partners and ensure clarity on goals. (David DeLuz).
- The Small Business webpage for District 11 is the easiest to find. Can we look at all the other district SB webpages to ensure they are up to date and available to contact? (Raewyn Butcher).
  - In District 4. The webpage will be revamped at the start of the year. D4 SB would like to collaborate on ways to improve the webpage. (Debra Nelson).
- As a Council, it would be nice to revisit our commitment and ensure that we are all as active as we can be. (Karen Nelson).
- Prompt pay; SB cannot stay in business if they are not paid promptly. It must be on the agenda. (Rebecca Llewellyn).
  - Can B2Gnow be implemented where it also tracks Minor B contracts?
     (Debbie Hunsaker).
    - With the implementation of B2Gnow, more prompt pay issues are being tracked. We need recommendations on how to improve this process. (David DeLuz).
    - In B2Gnow unapproved change orders fall through the cracks. As of today, I have been owed more than \$1.5 million. The issue with Minor B payments is the process. (Abd Jahshan, Guest).
      - B2Gnow is only for Construction-administered projects. There
        are Minor Bs that are not out of Construction. As far as the
        change order, we do have an HQ B2Gnow support unit that
        we oversee. Please email the Division of Construction (DOC)
        directly. (Lindsey Woolsey).
      - OCR should work with DOC to develop a communication or article to send out to our SBs and DBEs, that points them in

the direction of resources for prompt pay issues. (David DeLuz).

- One of the challenges is identifying how to create a process that monitors the contract process. DPAC is executing contracts, not monitoring. We must find a solution. (David DeLuz).
- There are not enough penalties for Primes who do not pay on time or work efficiently with subs. (Fred Jordan).
  - o This is on our list of issues to address. (David DeLuz).
