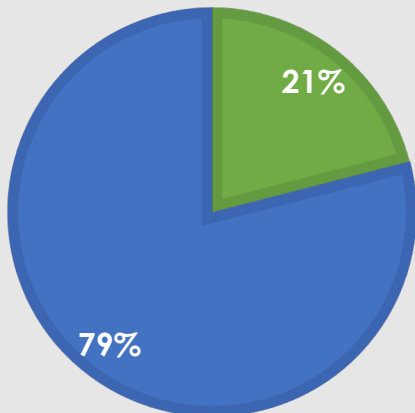

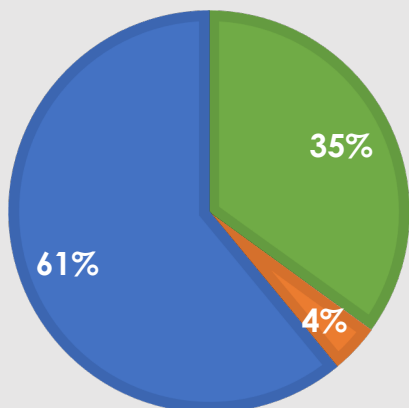

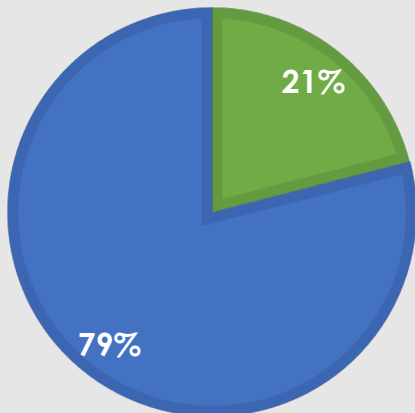

District 6 DBE, SB, and DVBE Participation at a glance:

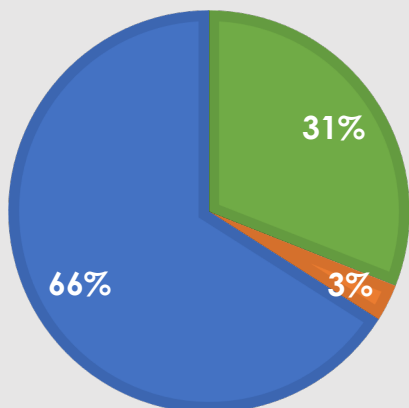
FEDERAL MAJOR CONSTRUCTION CONTRACTS TOTAL \$35,881,735

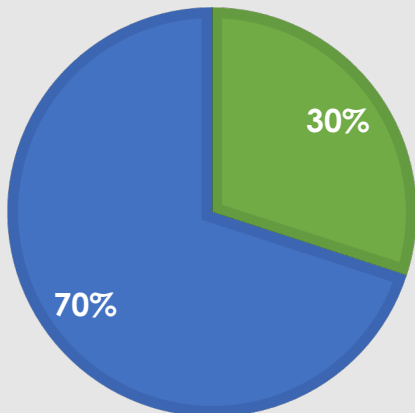

District 7 DBE, SB, and DVBE Participation at a glance:

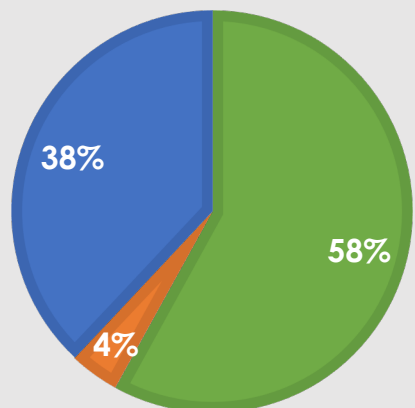

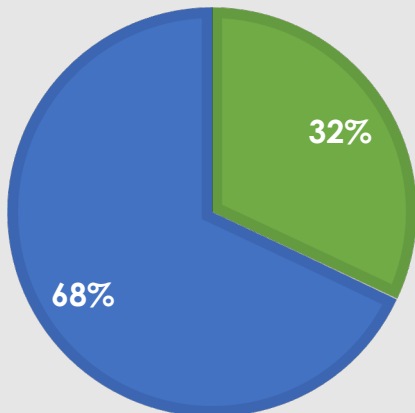

District 8 DBE, SB, and DVBE Participation at a glance:

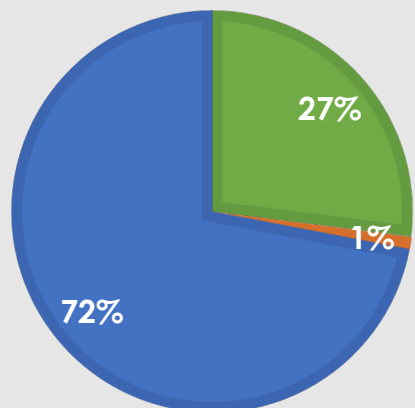
