Summary**

This report has been prepared pursuant to the Caltrans/FHWA Memorandum of Understanding (MOU) regarding State assumption of responsibilities under Section 327 of amended Chapter 3, Title 23, United States Code (23 U.S.C. 327). Caltrans reports annually to FHWA with a list of approvals and decisions Caltrans has made with respect to the responsibilities Caltrans has assumed under the NEPA Assignment MOU. This report provides a list of all reported 23 USC 327 approvals from January 1, 2023 through December 31, 2023 (Quarter 63 through Quarter 66).

Newly identified approvals from previous annual reporting periods are included in this report.
