Dear Ms. Boyer-Vine and Messrs. Alvarez and Wilson:

California's Government Code Section 16724.4, requires the lead California State agency administering State bond measure approved after January 1, 2004, to provide an annual report to the California State Legislature (Legislature) with a list of projects funded from bond proceeds. The list is to identify the geographic location, amount of funds allocated, and status of each project. The California Department of Transportation (Caltrans) is the administering agency for the Proposition 1B Public Transportation Modernization, Improvement, and Service Enhancement Account (PTMISEA). The PTMISEA includes \$4 billion with \$400 million allocated to the Caltrans for Intercity Rail and \$3.6 billion to be allocated to regional agencies and transit operators for transit systems.

A total of approximately \$2.75 billion has been allocated to regional agencies and transit operators for over 1000 projects. More than half of these projects have been completed and the rest are currently underway. Attached is a list of the projects receiving this funding. The full \$400 million from the PTMISEA has been committed to Intercity Rail projects.

California's Government Code Section 16724.4, requires the lead California State agency administering any State bond measure approved after January 1, 2004, to provide an annual report to the California State Legislature with a list of projects funded from bond proceeds. The list is to identify the geographic location, the amount of funds allocated, and the status of each project.

The California Department of Transportation (Caltrans) is the administering agency for the Proposition 1B Public Transportation Modernization, Improvement, and Service Enhancement Account (PTMISEA). The PTMISEA is a \$4 billion program which includes \$400 million allocated to Caltrans for Intercity Rail and \$3.6 billion to be allocated to regional agencies and transit operators for transit systems. The full \$400 million (less administrative costs) from the PTMISEA has been committed to Intercity Rail projects that commenced construction or procurement activities between March 2008 and June 2014. A total of approximately \$2.75 billion has been allocated to regional agencies and transit operators for projects or activities that are currently underway.

Background

The Public Transportation Modernization, Improvement, and Service Enhancement Account (PTMISEA) Program was created by the passage of Proposition 1B, the Highway Safety, Traffic Reduction, Air Quality, and Port Security Bond Act of 2006. Of the \$19.925 billion available to transportation, \$4 billion dollars was allocated to the California Department of Transportation (Caltrans) for intercity rail projects and for commuter or urban rail operators, bus operators, waterborne transit operators, or other transit operators in California. The PTMISEA Program provides funding for rehabilitation; safety or modernization improvements; capital service enhancements or expansions; new capital projects; bus rapid transit improvements; or for rolling stock procurement, rehabilitation, or replacement, over a ten-year period.

General obligation bond law requires the administrative agency to submit a report to the California State Legislature no later than January 1st each year. This requirement is found in California Government Code section 16724.4. In addition, this section states that the report shall contain:

- (1) A list of all projects and their geographical location that have been funded or are required or authorized to receive funds.
- (2) The amount of funds allocated on each project.
- (3) The status of any project required or authorized to be funded.

Caltrans has established the Proposition 1B Bond Accountability website and has posted this information related to each project. Caltrans administered programs can be accessed from the Intercity Rail Improvement and the PTMISEA links at this address:

Mass Transportation Program Proposition 1B Bond Fund

Of the \$4 billion available in PTMISEA, \$3.6 billion is to be allocated to transit operators over a ten-year period. The PTMISEA Program was designed to help advance the State's policy goals of providing mobility choices for all residents, reducing congestion, and protecting the environment. Guidelines for the PTMISEA Program were developed through a cooperative effort with stakeholders. Eligible transit projects include:

- Rehabilitation, safety, or modernization improvements.
- Capital service enhancements or expansions.
- New capital projects.
- Bus rapid transit improvement.
- Rolling stock procurement, rehabilitation, or replacement.

Status

To date, PTMISEA has released \$2.74 billion for over 1,000 projects. The following is a breakdown by Fiscal Year (FY):

^{*}The FY 2010-11 appropriation was intended to cover three years of funding. There were no additional appropriations of PTMISEA funds in the FY 2011-12, FY 2012-13, or FY 2013-14 Budgets. \$793 million has been appropriated in the FY 2014-15 Budget.

^{**}Some allocations were made to existing projects. The total number of PTMISEA projects funded to date is lower than the total sum of each cycle's number of projects receiving allocations. For example, the San Francisco Central Subway project received allocations in six different cycles. It would be included in the number of projects receiving allocations each time, but it is only counted as one project overall.

^{***}Government Code 8879.55 (d) (1) calls for Caltrans to develop a list of projects biannually. This coincides with spring and fall bond sales. The FY 2010-11 appropriations includes more than two cycles because additional appropriations were not made until FY 2014-2015. Each year for 2010-2011 through 2013-14, there were two cycles of funding.

Intercity Rail Improvement Program (IRI) Proposition 1B Bond Fund

In FY 2013-14, the Proposition 1B Intercity Rail Improvement (IRI) Program consisted of sixteen projects, two projects remain unallocated, three projects are partially allocated, eleven projects are fully allocated, and five projects are completed. These projects total 51 percent of the \$392,050,000 available for allocation.

The PTMISEA account is used to fund public transportation projects. Pursuant to Paragraph (2) of Subdivision (c) of Section 8879.50 of the Government Code, Caltrans is the administrative agency for PTMISEA.

At its December 2007 meeting, the California Transportation Commission (Commission) approved the guidelines for intercity passenger rail projects in the PTMISEA. The IRI Program is a \$400 million element of the \$4 billion Proposition 1B PTMISEA. At its February 2008 meeting, the Commission approved the list of Proposition 1B intercity rail projects to be funded in the IRI. The Commission last amended the list of projects in June 2014. Specific to the Intercity Rail Improvement program, a minimum of \$125 million from the \$400 million is designated for procurement of additional intercity passenger railcars and locomotives.

Fiscal Year End Project Status:

Procure New Railcars and Locomotives—This project is programmed for \$150 million in PTMISEA funds (Statute requires \$125 million to be used for the procurement of intercity passenger railcars and locomotives). To date, \$42 million has been allocated.

Passenger Railcars—Currently, 42 bi-level passenger railcars are being built by Nippon Sharyo Manufacturing in Rochelle, Illinois. Caltrans is the lead for this multi-state railcar procurement. Preliminary, Intermediate, and Mockup car design and review are complete. Final design review is near completion and Caltrans is in the review stage of Design drawing review and approvals. Several system safety and hazard analysis tests and test procedures have been performed and approved. First Article Inspections are currently being planned and scheduled. The first article inspection is an examination and approval by the customer of an initial production component by the contractor or subcontractors.

Locomotives—Currently, six new locomotives are being built by Siemens Industry Inc. in Sacramento. The Illinois Department of Transportation (IDOT) is lead of the multi-state locomotive procurement effort. The Master Agreement for the Multi-State Locomotive Procurement was executed in March 2014, and Caltrans' Ordering Agreement was executed on April 3, 2014. On April 14–15, 2014, Caltrans participated in the project kick-off meeting at Siemens. Preliminary Design Review (PDR) meetings were held in May and June 2014. The Joint Purchasing Agreement with Caltrans is working with IDOT and Washington State Department of Transportation to review all PDR action items and all contractual deliverables submitted to date.

New Station Tracks at Los Angeles Union Station—An allocation of \$21.8 million is funded for this project. The project is 97 percent complete and is on schedule to be fully completed by June 30, 2015. At the December 2013 Commission meeting, \$13.3 million of unallocated funds from New Station Tracks was reprogrammed to Van Nuys North Platform Station and Raymer to Bernson Double Track project.

San Onofre to Pulgas Double Track Project—Phase 1—On July 16, 2013, the San Diego Association of Governments (SANDAG) received six bids for the project. On September 27, 2013, SANDAG Board approved the Construction Award. On February 14, 2014, clearing sensitive habitat was completed. Grading and drainage work is progressing along with the construction of pier protection walls under Interstate 5.

Northern California Maintenance Facility—At the August 2013 Commission meeting, funds for Right of Way and Construction were programmed to this project from the deprogrammed Mid-Route Layover Facility. At the December 2013 Commission meeting, this project was renamed from Sacramento Maintenance Facility to Northern California Maintenance Facility. Currently, this project is unallocated for Proposition 1B Intercity Rail Improvement Program (ICR1B) funds. The proposed allocation date is December 2015.

Oakley to Port Chicago—Construction is 47 percent complete and is on schedule for completion June 2015. Milestones include upgrading Sando Siding to increase speed to 30 mph from previous speed of 10 mph. Grade crossing at Wilbur Lane was upgraded. Burlington Northern Santa Fe Railway installed a universal crossover at the east end of the project in the city of Oakley.

Coast Daylight Track and Signal—The project is currently unallocated with an anticipated date of January 2016 for environmental clearance and phase completion.

Santa Margarita Bridge and Double Track-Construction is 100 percent complete. On April 11, 2014, all remaining physical work activities were completed. This project is in the closeout phase.

Wireless Network for Northern California Intercity Passenger Rail Fleet—Base installation of Wi-Fi System is complete. Additional upgrades to the technology, which changes rapidly, will ensure the systems on the Northern California Fleet will be functioning to the latest advisable technology and performance standards.

Raymer to Bernson Double Track—At the December 2013 Commission meeting, an additional \$9.3 million was programmed to this project from the New Station Track project for a total of \$16.8 million. An allocation request for final design was approved for \$6.5 million at the January 2014 Commission meeting. In April 2014, a contract was awarded for design. For the remaining ICR1B construction funds, the proposed allocation date is June 2016.

Van Nuys North Platform—At the December 2013 Commission meeting, the Commission approved to amend the ICR1B project list to add the Van Nuys North Platform project to be funded with \$30.5 million from the deprogrammed Commerce/Fullerton Triple Track—Segment 8 project and \$4 million from the New Station Track at LA Union Station project. Also, an allocation request for design was approved for \$4 million for the Van Nuys North Platform.

Capitol Corridor Track, Bridge and Signal Upgrade—At the May 2014 Commission meeting, the Commission approved to amend the ICR1B project list to add the Capitol Corridor Track, Bridge and Signal Upgrade project, to be funded with \$1,305,000 from the Bahia Benicia Crossover project's savings. Also, an allocation request for construction was approved for \$1,305,000.

Completed Projects:

Commerce/Fullerton Triple Track Segment 6—At the June 2014 Commission meeting, the Commission approved to amend the ICR1B project list to de-allocate \$8,000 in project savings. The project has been completed for a total project amount of \$31,992,000.

Emeryville Station and Track Improvements—At the June 2014 Commission meeting, the Commission approved to amend the ICR1B project list, to de-allocate \$99,000 in project savings. The project has been completed for a total project amount of \$6,151,000.

Bahia-Benicia Crossover and Track Improvement Project-The project is 100 percent complete with a savings of \$1,305,000. At the May 2014 Commission meeting, the Commission approved to amend the ICR1B project list to de-allocate \$1,305,000 in project savings and place the funds on a new project, the Capitol Corridor Track, Bridge and Signal Upgrade Project. An ICR1B Closeout Report was completed on March 4, 2014.

Southern California Regional Rail Authority (SCRRA) Sealed Corridor—Project became operable November 2013. The project is 100 percent complete with a savings of \$218,000 and an ICR1B Closeout Report was completed March 4, 2014. At the August 2014 Commission meeting, the Commission approved to amend the ICR1B project list to de-allocate \$218,000 in project savings. The project has been completed for a total program amount of \$2,782,000.

Projects Removed from IRI Program:

Commerce/Fullerton Triple Track Segment 8–Funding for Segment 8 has been obtained through Traffic Congestion Relief Program savings from the Valley View Grade Separation Project. At the December 2013 Commission meeting, the Commission approved to amend the ICR1B project list to delete this project and reprogram \$30.5 million on a new project, Van Nuys North Platform.

Mid-Route Layover Facility (formerly Fresno Layover Facility)—At the August 2013 Commission meeting, the Commission approved to amend the ICR1B project list to delete the Mid-Route Layover Facility project, and to reprogram \$14.601 million to the Sacramento Maintenance Facility project, which was renamed to the Northern California Maintenance Facility.
