The OFR's amount is based on the Federal Highway Administration (FHWA) FY 2022 OA notice (FHWA N4520.274) dated April 1, 2022. The OA spread between regions and programs was also updated based on the Department's Division of Financial Programming FFY 2022 Actuals apportionment distributions issued on October 21, 2022.

² Balance of FFY 2021 OA (last FFY's OA balance) --- This is the amount a Region/Program must pay back if over delivered or the amount a Region/Program will receive to "make whole" if under delivered based on the Division of Local Assistance's (DLA's) OA Management Policy. Amounts shown in parenthesis are amounts owed and positive (non-parenthesis numbers) amounts are to be repaid to Regions/Programs. ⁷In March 2022, \$60,000,000 of Local federal-aid Safety apportionments and OA were transferred to OFR per Reference 2.5h from the June 23-24, 2021 and Reference 2.5h from the October 13-14, 2021, California Transportation Commission meetings, in exchange for State Highway Account (SHA) funds. The transfer and exchange is allowed per Senate Bill (SB) 137 (Chapter 639 of the 2019 Statutes), effective October 8, 2019, which authorized the Department to allow up to \$100,000,000 of federal Local Assistance funds to be exchange for SHA funds. The purpose of the exchange is to fund local Highway Safety Improvement Program (HSIP) projects with State and local funds. The exchange will lead to increased efficiency for local agencies by reducing the time and resources needed to delivery HSIP projects.

⁸The IIJA final funding split for the Carbon Reduction Program (CRP) and the Promoting Resilient Operations for Transformative, Efficient, and Cost-Saving Transportion Program (PROTECT) is finalized. CRP and PROTECT OA will be treated similar to HBP and Safety because PROTECT is being administered by the CTC and CRP apportionment distributions are not finalized yet.

⁹OA increased by \$1,271,963 due to State to State transfer from Nevada to California for project STPLN-6478(005) (Tahoe).

¹⁰ In June 2022, \$1,090,677 of Repurposed Earmark funds were obligated for project 6211(131) and counted as part of SANDAG's OA usage. In August 2022, the Repurposed Earmark funds were changed on the FMIS W10A from "Apportioned Programs" to "Allocated Programs" which also changed the type of OA used for the transaction. The \$1,090,677 was removed from SANDAG's OA usage amount in the August 2022 OA Delivery report.
