Statement of Effort/Improvement

Section 94 includes specifications for furnishing asphaltic emulsions. However, there are four emulsions currently used by Caltrans that are not included in Section 94 but are specified in Section 37 or 39 and in an NSSP. Currently Section 94 is silent on the furnishing requirements for these four emulsions. Since Section 94 needs to be revised, the working group will also review the following technical content listed in the attached *Section 94 Review Table* to update Section 94.

Purpose

The purpose is to include the furnishing specifications for four emulsions into Section 94 which are currently not in the Section 94 but are referenced in Sections 37, 39 and an NSSP. The technical content in Section 94 hasn't been reviewed since the 2006 Specification's revision. This is an opportunity for the working group to review and decide which content shall be included in the revision. These are the known technical issues with Section 94 that need to be reviewed:

- Include four emulsions into Section 94 that already exist in other Caltrans Specifications
 - o From RSS Section 37-3.02B(3) PMCQS-1h Emulsion for Slurry Seal
 - o From RSS Section 37-3.03B(2) MSE Emulsion for Micro Surfacing
 - o From Section 39-2.05A(1)(d)(iii) PMAEM Emulsion for Bonded Wearing Course
 - From Scrub Seal NSSP 37-2.07B(2) PMRE Emulsion for Scrub Seal or Chip Seal
 - Update PMCRS-2h specification table to include tests required in Section 37-2.03B(2)

- Remove the four emulsions furnishing specifications from Sections 37, 39 and NSSP.
- Add CRS-1h and CRS -2h to Table for Rapid Setting Cationic Emulsions instead of specification via footnote.
- Review and update identified testing method issues and procedures for consistency across all tables
- Review viability of Section 94 emulsion products for compliance with current CA Air Quality Requirements. Remove them if they won't meet the requirements.
- Add sample storage, handling, and testing time requirements for all emulsions in accordance with AASHTO recommendations

Background

Section 94 has not been thoroughly reviewed for technical content since the 2006 Specification Revision. The four asphaltic emulsions listed above are currently used by Caltrans are specified in Sections 37, 39 or in a NSSP but are not currently included in Section 94. Section 37, 39, or NSSP include general specifications for applying bituminous seals whereas Section 94 includes specifications for furnishing asphaltic emulsions. This effort by working group is going to include the furnishing specifications in Section 94 that are currently in Section 37, 39 and NSSP.

There are some technical advancements in the asphaltic emulsions since the 2006 Standard Specification revision that shall be considered to be included into the Section 94 update.

Approach

1. Street Ready Assurance

The working group will work with Industry, Construction, METS, and Asphalt Pavements to review existing specification for any technical issues, add four emulsions and then circulate the revised specification for comments from Industry, Construction, Design and METS personnel for any fatal flaws.

2. Performance Tracking/Management

Periodic reviews by subtask group to insure changes aren't creating problems for Construction or Industry.

3. Consistently Implemented

Working with Industry, Construction, METS, and Design to provide a transmittal memo and Construction manual update on the changes made to Section 94 to the districts.

4. Pilot Projects (if anticipated)

No pilot projects are anticipated.

Benefits

- This will benefit Caltrans and the suppliers by raising awareness of available materials by including specification requirements for all asphaltic emulsions in a central location, Section 94.
- Removal of emulsion furnishing specification requirements from Section 37, 39 and NSSP and placing them in the correct location, Section 94, will aid the Engineer when building projects and referencing materials.
- The technical content hasn't been reviewed since 2006. This effort would bring Section 94 to be current with the latest developments and correct issues with specification language that could cause issues with testing that could lead to claims in construction.

Estimated Impact to Caltrans and Contractor -

- Bring consistency in specifying furnishing requirements of the asphaltic emulsions.
- Update Section 94 for technical content.
- Bring clarity to the furnishing specification of asphaltic emulsion in Section 94.
