3. Update on Scoping Documents

- I. **Concrete Smoothness**: The Working Group does not expect to see any data evaluation until the end of this calendar year. Dulce will maintain an updated list of projects where the NSSP has been applied.
- II. **Limited Construction Windows:** The FHWA (Jagan Gudimettla and Mike Praul) had a Mobile Concrete Technology Center (MCTC) Workshop in Sacramento, CA on June 5, 2019 and addressed maturity testing for opening to traffic.

- I. Dulce will share the Low Flexural Strength spec language with the STG on CIP STG. In Progress

5. Updates on Other Activities

- I. Evaluation of Concrete Pavement Represented by Low Flexural Strength Test: Dulce is pushing the specification language through OE top get into the next RSS (Oct 2019). For disputes on current projects, RE's should contact Dulce and Deborah.
- **II. Implementation of ASTM C78 through the replacement of CT 523**: A Scoping Document was approved for this effort by the PMPC Concrete Materials STG. METS plans to change the CT 523 so it refers to ASTM C78/31.
- III. Implementation of Smoothness NSSP: Caltrans Pavement Program has visited each district to provide internal training on the smoothness NSPs. This outreach was complete by the end of March. Dulce with the Caltrans Office of Concrete Pavement, Deborah with the Office of Construction Standards and Charles with the Concrete Pavement Industry in California (Charles) worked together to have a concrete pavement industry outreach in collaboration with Caltrans. Three dates for this industry outreach were done in May 2019.
