- 1. Introductions/Review Agenda/Past Action Items
- 2. Pavement Smoothness
 - a. Memo for additional time sent through to October 2021
- 3. Limited Construction Windows
 - a. Kuo-Wei's staff had comments on the report
 - b. Concerned that removing the 10-day requirement could lead to situations where concrete is not evenly cured. Contractor to provide verification of when concrete reached 550 psi. Now, no strength test requirement specified for opening age.
 - c. Report to go back to STG to address comments prior to CTG review
 - d. Milestones may need to be adjusted
- 4. Precast Pavement Phase II
 - a. Memo for additional time sent through to Oct 2021
- 5. 4x8 Cylinders
 - a. Patrick Lo, Aggregate Senior, working on this
 - b. Once this comes in, Keith to send to CTG
 - c. Outreach at many different meetings to get word out to construction of this change
 - d. Test methods signed to Dan that had a link to Lab Safety Manual, but had not been ADA reviewed. Language changed to remove link and to "use appropriate Lab Safety Manual." Should be signed by Dan soon.
- 6. Concrete Mix Design
 - a. 10/31/2019 milestone for spec publication will not be met
 - b. Brett's group completed the final draft and sent to Jeff Goronea
 - c. Brett to send to final draft to Dulce as well
- 7. Recycled Crushed Concrete Aggregate
 - a. Deepak's work group sent the proposed recommendation report to the subtask team
 - b. STG saw the first report and was sent back for updates
 - c. Scoping document states CTG approval required to move to next milestone
 - d. Jackie to finalize report and submit to CTG for review
 - e. Jackie to write letter for extension
- 8. CT 523 Flexural Beam
 - a. Possibly replaced by Compressive Strength acceptance tests
 - b. Likely CT 523 still used for correlation results
 - c. Samir to get CPD attachment routed for comments
 - d. Chu Wei with FWHA may have questions about this change. Kuo-Wei to have someone prime Chu before he reads it to speed up approval.

- 9. Review of bin lists
 - a. No scoping documents required for projects to be added to Bin List
 - b. EC wants to see short scoping document only as a draft for the full scoping document
 - c. Memo regarding adding Concrete Pavement acceptance based on Compressive Strength to the CTG Bin List.
 - i. Additionally, change acceptance time from 28 days to 42 days
 - ii. Most states accept pavement by compressive strength
 - iii. Dulce to clarify Memo on what the acceptance criteria is proposed to be
 - iv. Kuo-Wei to work with Dulce to develop Memo
 - v. Approval via email sufficient to move this task forward to EC
 - d. Corrosion related specifications AASHTO adding a differentiation between corrosive and marine environments.
 - i. Approved by DES committee
 - ii. Jackie to form Team for this task including industry and pavement
