1. Is there a Union Requirement?

2. Has the RFP / RFQ been published?

**This is an RFQ only. The RFQ is estimated to be advertised on Cal eProcure in December 2022.**

**We are open to fair competition and yes, a small company can be awarded this contract. The information regarding the primes will be posted based on the outreach attendance list.**

4. How do we reach out to primes?

5. How do we get or reach out to primes? Why is the anticipated DBE goal 18% when the CT goal is 22.2%?

**This is a statewide goal and set by Office of Civil Rights. The specific contract goals are set depending on certain factors. The goal minimum is within all our contracts to meet that.**
