# **Consent Items**

19-01 Legislative Change (SB 842) and the proposed changes to the CA MUTCD Senate Bill 842 (SB 842) requires Caltrans to erect, at appropriate locations on highways in the state highway system, generic directional signs to each Veteran's Home of California.

Action: The Committee approved the requested Veterans Home of California sign.

- 19-02 Alternative Pedestrian Hybrid Beacon Sign Discussion: The proposed sign wording "CROSSWALK, STOP ON RED, PROCEED ON FLASHING RED WHEN CLEAR" was not agreed upon as clear language. The Committee decided to table the item. Committee Member Tong stated that he would work with the FHWA and CHP to come up with better language for the sign.
- 19-03 Proposal to Section 6F.109(CA) Construction Funding Identification Signs Action: The Committee approved adding the C48(CA) sign to Section 6F.109(CA) and to Figure 6F-101(CA).
- 19-07 Legislative Change by AB 634 and the proposed changes to the CA MUTCD Assembly Bill 634 (AB 634) requires that roundabouts be included in the list of highway facility types that may be used for memorial or dedication signing in the CA MUTCD.

Action: The Committee approved the addition of the memorial signs at roundabouts.

Discussion: The Committee brought up concerns that adding additional signs to roundabouts could dilute the warning signs on the roundabout approaches. Multiple Committee Members stressed the importance of carefully placing additional signs at roundabout approaches.

19-09 Bicycles travelling straight from Exclusive Turn Lanes Assembly Bill 1266 (AB 1266) will allow bicyclists traveling straight through an intersection from a right- or left-hand turn only lane if an official traffic control device indicates that the movement is permitted.

Action: The Committee approved adding language to the CA MUTCD Section 9C.07 Shared Lane Markings in addition to adding Figures 9C-111(CA) and 9C-112(CA).

# **Action Items**

17-21 Legislative Change by AB 390 and the proposed changes to the CA MUTCD Assembly Bill 390 (AB 390) allows pedestrians facing a flashing "DON'T WALK," "WAIT," or "Upraised Hand" symbol with a "countdown" signal to enter the crosswalk to cross the roadway.

Action: The Committee approved changes to the CA MUTCD Section 2B.52, Figure 2B.26, and the addition of two new signs: R10-3e(CA) and R10-3i(CA).

- 19-06 Proposed Change to Section 2B.13 Action: The Committee approved changes to the CA MUTCD Section 2B.13. The agency changing the posted speed limit will be required to inform the agency operating the traffic signals about the new speed limit no later than 30 days before changing the posted speed limit.
- 18-11 Yellow timing sub-committee Action: The Committee approved the deactivation of the sub-committee.

# **Request for Experimentations**

- 12-21 Request for approval of In-Roadway Warning Lights (IRWL) System Final Report Action: The Committee received and approved the final report and approved the request to let the video equipment stay in place in the field as installed. The experiment showed that the inroad Internally Illuminated Raised Pavement Markers (IIRPMs) parallel to the light rail train tracks significantly reduced the number of turning violations versus when the lights were off.
- 16-33 Request for approval of Non-Standard Striping Detail at Express Lanes Action: The Committee received and approved the final report. The experiment was determined to be non-conclusive. The Committee also accepted the recommendations to remove the solid/skip line and replace it with the standard detail and to leave the double stripe in place without the raised pavement markers.
- 18-16 Experiment closeout Final Report: Red pavement treatment Action: The Committee approved the experiment's final report and moved it to the FHWA for acceptance. The red pavement treatment for transit lanes in San Diego were determined to be very effective in reducing violations of transit only lanes.
- 19-04 Request for experimentation with Non-standard roadside sign ALL/VEHICLES/MUST/HAVE/FasTrak<sup>™</sup>LOGO/TRANSPONDER Action: Request for experiment was approved to allow for new signage for Express Lanes. The proposed sign will read "ALL VEHICLES MUST HAVE FASTRAK TRANSPONDER."
- 19-05 Request for experimentation Request to Experiment with Bidirectional Pavement Marking Action: Request for experiment was approved with advice that arrows not be applied to crosswalk marking surfaces. The proposal is to install LaneAlert 2x<sup>™</sup> which displays a warning message or symbol to a driver approaching the reflective pavement marking or striping from the wrong direction.
- 19-08 Non-standard traffic control device Signing and pavement markings for Highway 1 bus on Shoulder project
  Action: The Committee approved the request for experimentation contingent with amendment that District 5 could implement red pavement should they find they have an enforcement issue.
- 19-11 Red colored transit-only lanes Action: The Committee approved the request for experimentation. LA DOT will experiment with red colored transit-only lanes to determine if they reduce violations of transit-only lane restrictions and reduce delays to transit vehicles.

#### **Discussion Items**

18-08 Report on Changes to the Minimum Yellow Light Change Interval timing for Signalized Intersections

Discussion: Vice-Chair Bahadori reported that the subcommittee members had reached consensus that the CA MUTCD as currently written in insufficient in regarding the issue of minimum yellow timing for traffic signals. The subcommittee will prepare a paper to find an appropriate minimum yellow light time and will continue to meet quarterly to resolve this issue.

19-12 Electric Bicycles on Class I Bikeways Discussion: Caltrans is considering developing signage for Class I bikeways to indicate which types of electric bikes are allowed. Per CVC 21207.5, Class 1 and Class 2 Electric bikes are allowed on Class I bikeways, unless there is an ordinance prohibiting their operation. Class 3 Electric Bikes are not allowed on Class I bikeways, but they may be allowed if an ordinance allows it. The Committee discussed including signs which will specify which types of electric bikes are allowed, but they determined that Class I bikeway speed limit signs should be considered instead. The Committee did not recommend electrical bicycle class signage.

## 19-13 Target Compliance Dates

Discussion: Committee Member Tong reminded all the present agencies of the upcoming Target Compliance Dates Established by the FHWA.

#### **Information Items**

19-10 NTSB Report Recommendations and the proposed changes to the CA MUTCD NTSB published a report in response to a fatal collision at the interchange of US Highway 101 and State Route 85. NTSB submitted recommendations proposing changes to the CA MUTCD language for gore areas at off-ramps.

Action: The Committee approved changes to the CA MUTCD Section 3B.05, Section 3B.24, and Figure 3B-8(CA). The approved changes require that chevrons be placed at exit ramp gore areas, but they remain optional at entrance ramp gore areas.
