You are consulting with me about the subject undertaking in accordance with the January 2014 *First Amended Programmatic Agreement Among the Federal Highway Administration, the Advisory Council on Historic Preservation, the California State Historic Preservation Officer, and the California Department of Transportation Regarding Compliance with Section 106 of the National Historic Preservation Act, as it Pertains to the Administration of the Federal-Aid Highway Program in California (PA)*.

Caltrans has determined that the following properties are not eligible for the National Register of Historic Places (NRHP):

- 1381/1401 Franquette Avenue, Concord, CA
- 1440/1476 Franquette Avenue, Concord, CA
- 1480 Franquette Avenue, Concord, CA
- 1420 Danzig Plaza, Concord, CA
- 1891 Market Street, Concord, CA
- 1810 Market Street, Concord, CA
- 1585 Clayton Road, Concord, CA

Based on my review of submitted documentation I concur with the foregoing determinations.

Caltrans has also found the Mokelumne Aqueduct (pipeline #3), west of State Route 242, to be not eligible for the NRHP. I agree that pipeline #3 is not a contributing element of the Mokelumne Aqueduct and is not individually eligible on its own.






Project Area

-  1 Mile Buffer





Figure 1: Project Location

Good Morning Mr. Galvan,

I'm not sure if Sean wrote you back so if you receive your answer twice, I apologize. You asked what were the archaeological recommendations to the client based on the literature search and foot survey for the SR-242 Clayton Road Ramps project. I have reviewed the Archaeological Survey Report, which is in progress still and it states that we are recommending the installation of an Environmental Sensitivity Area (ESA) fence be installed around the mapped location of the Beebe House site to prevent possible construction impacts to potentially eligible cultural resources. The Beebe House, CA-CCO-648H, is an historical site located with the Project's horizontal APE. The Beebe House site is likely located outside the Project's vertical APE. The site has not been evaluated for eligibility for listing on the National Register of Historic Places; however, it may be eligible under Criteria A and D for its association with an important figure in local history and the data potential of the subsurface component.

Archaeologists noted no surface indicators of archaeological soils or cultural resources within the Project APE; however, there is the potential of encountering unrecorded cultural resources.

We are recommending that construction halt within a 100 ft. radius if workers encounter potential cultural resources (i.e., structure/building remnants, bottles, glass, ceramics, stone tools, etc.) until a qualified archaeologist can assess the find and follow the proper protocols for the specific type of cultural material discovered. If the discovery is determined to be a unique archaeological or historical resource under the criteria of the National and California Register of Historical Resources after review and evaluation by a professional archaeologist; and if avoidance of the resource is not possible, Condor Country Consulting, Inc.

recommends that a professional archaeologist develop plans for treatment of the find(s) and mitigation of impacts acceptable to Caltrans. The archaeologist shall design the treatment plan to result in the extraction of sufficient non-redundant archaeological data to address important regional research considerations. The archaeologist would perform this work, produce a detailed technical report, and file the report with the California Historical Resources Information System (CHRIS), Northwest Information System Center (NWIC). Construction within a buffer determined by the qualified archaeologist should not resume until the archaeologist has finished any necessary treatment of the find.

In accordance with California Health and Safety Code section 7050.5 and pursuant to California Public Resources Code sections 5097.94, 5097.98, and 5097.99, Condor Country Consulting, Inc. recommends that if human remains are uncovered during ground disturbances, workers halt construction within a 100 ft. radius of the discovery and immediately notify the Caltrans Resident Engineer. Caltrans will immediately notify the Contra Costa County Sheriff-Coroner (925-313-2850) and halt work until the coroner's office has completed their investigations. The County Coroner is required to examine all discoveries of human remains within 48 hours of receiving notice of discovery. If the Coroner believes, or has reason to believe, that the human remains are those of a Native American, the Coroner is required to contact the NAHC within 24 hours of making that determination. The archaeologist and NAHC designated Most Likely Descendent will determine the ultimate treatment and disposition of the remains.
