Dear Contractor:

This addendum is being issued to the contract for construction on State highway in SANTA CLARA COUNTY IN SAN JOSE FROM ROUTE 280/680/101 SEPARATION TO 0.3 KM SOUTH OF BIRD AVENUE OVERCROSSING.

Submit bids for this work with the understanding and full consideration of this addendum. The revisions declared in this addendum are an essential part of the contract.

Bids for this work will be opened on October 26, 2004.

This addendum is being issued to revise the Notice to Contractors and Special Provisions.

In the Special Provisions, Section 4, "BEGINNING OF WORK, TIME OF COMPLETION AND LIQUIDATED DAMAGES," the third and fourth paragraphs are revised as follows:

"The work shall be diligently prosecuted to completion before the expiration of **75 WORKING DAYS** beginning on the fifteenth calendar day after approval of the contract.

The Contractor shall pay to the State of California the sum of \$8,000 per day, for each and every calendar day's delay in finishing the work in excess of **75 WORKING DAYS**."
