This addendum is being issued to the contract for CONSTRUCTION ON STATE HIGHWAY IN RIVERSIDE COUNTY IN MORENO VALLEY AND BEAUMONT FROM DAY STREET UNDERCROSSING TO ROUTE 10/60 SEPARATION.

Submit bids for this work with the understanding and full consideration of this addendum. The revisions declared in this addendum are an essential part of the contract.

Bids for this work will be opened on Thursday, May 20, 2010.

This addendum is being issued to revise the Notice to Bidders and Special Provisions and the Federal Minimum Wages with Modification Number 3 dated 04/16/10.

In the Special Provisions, Section 2-1.03, "DISADVANTAGED BUSINESS ENTERPRISES," subsection "Good Faith Efforts Submittal," the following paragraph is added after the last paragraph:

"The Department may consider UDBE commitments of the 2nd and 3rd bidders when determining whether the low bidder made good faith efforts to meet the UDBE goal."

To Bid book holders:

Inquiries or questions in regard to this addendum must be communicated as a bidder inquiry and must be made as noted in the Notice to Bidders section of the Notice to Bidders and Special Provisions.
